APPLICATIONS INVITED FOR THE POST OF DEPUTY CHIEF MECHANICAL ENGINEER (ELECTRICAL/ELECTRONICS & COMMUNICATION), COCHIN PORT TRUST BY ABSORPTION THROUGH COMPOSITE METHOD

- 1) Applications are invited for filling up one post of Dy.Chief Mechanical Engineer(Ele./E&C) in the Scale of Pay of Rs.32900-58000 (Pre-revised Rs.16000-20800) in Cochin Port Trust by absorption through composite method from Officers holding analogous posts or the posts of Superintending Engineer and equivalent posts in the Electrical /Electronics & Communication discipline of M&E Engg.Deptt. in the Scale of pay of Rs.24900-50500 (Pre-revised Rs.13000-18250) with three years regular service in the grade in the Electrical /Electronics & Communication discipline in a Major Port Trust or Superintending Engineer and equivalent post in the Electrical /Electronics & Communication discipline of M&E Engg.Deptt. with two years regular service in the grade and a combined regular service of seven years in the Scales of Pay of Rs.20600-46500 (Pre-revised Rs.10750-16750) and Rs.24900-50500 (pre-revised Rs.13000-18250) in the Electrical /Electronics & Communication discipline in a Major Port Trust. 5. The applications received through proper channel only will be entertained. The applications received after the last date or without ACRs and other requisite documents or otherwise incomplete will not be considered.
