## I. Professor

Eligibility (A or B) :

A.

i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in UGC Regulations, 2018.

ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

## OR

**B.** An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant



contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience

## **II. Associate Professor:**

### **Eligibility:**

i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.

ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).

iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in UGC Regulations, 2018.

### **III. Assistant Professor:**

## Eligibility (A or B) :

### A.

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET :

*Provided*, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions :-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;

d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;

e) The candidate has presented at least two papers based on his/her Ph.D work in

conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET shall also not be required for such Masters Programmes in disciplines for which NET is not conducted by the UGC, CSIR.

#### OR

**B.** The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for Universities, and Appendix II (Table 3B) for Colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

*Provided*, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions:-

a) The Ph.D. degree of the candidate has been awarded in a regular mode;

b) The Ph.D. thesis has been evaluated by at least two external examiners;

c) An open Ph.D. viva voce of the candidate has been conducted;

d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;

e) The candidate has presented at least two papers based on his/her Ph.D work in

conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Vice Chancellor/Pro Vice Chancellor/ Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET shall also not be required for such Masters Programmes in disciplines for which NET is not conducted by the UGC, CSIR in the disciplines notified by the Central University of Kerala.

2. A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.

**3** . A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Noncreamy Layer/ Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

4. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to19 September, 1991.

**5.** A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.

6. The Ph.D. Degree shall be a mandatory qualification for appointment and promotion to the post of Professor.

7. The Ph.D. Degree shall be a mandatory qualification for appointment and promotion to the post of Associate Professor.

8. The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the

purpose of direct recruitment/ promotion. Regular faculty members upto twenty per cent of the total faculty strength (excluding faculty on medical / maternity leave) shall be allowed by their respective institutions to take study leave for pursuing Ph.D. degree.

9. Candidates applying for the reserved posts should clearly state the category they belong to. They must also enclose self-attested photocopy of caste certificate/medical certificate from the competent authority. Caste certificate to be produced by SC/ST candidates and Non –creamy layer certificates by the candidates claiming OBC reservation should be in the format prescribed by the Govt. of India. The candidates applying for posts reserved for EWS and PWD should submit the certificate in the prescribed format.

## 10. Persons in service should apply through proper channel.

11. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received are large and/or where it will not be convenient or possible to interview all the candidates, the University at its discretion may restrict the number of candidates to a reasonable limit on the basis of higher qualifications/experience than that prescribed in the advertisement. Further, the University may also fill up the posts advertised on short-term contract basis if necessary.

12. Changes in Regulations on qualifications, experience, age, calculation/application of API Scores, etc. issued by the UGC subsequent to this notification will become mandatory from the respective dates of effect prescribed. Applicants are advised to visit the UGC Website (www/ugc.ac.in), MHRD/AICTE,NCTE etc for latest revision/changes which will be applicable at the time of interview.

**13**. The University reserves the right to –

(a) not to fill up any or all posts advertised.

(b) Offer a post at a lower/higher level than notified, depending upon the qualifications, experience and performance of a candidate

(c) relax any of the desirable qualifications/experience at its discretion for reasons to be recorded.

14. The eligibility, age, qualification etc prescribed shall be as on the last date of receipt of application.

**15**. Candidates possessing foreign degrees should submit Equivalence Certificate issued by the Association of Indian Universities (AIU) at the time of interview, if called for.

16. Outstation candidates (beyond 20 km) belonging to SC/ST/DA categories called for interview will be reimbursed single second-class railway fare from station to station towards journey expenses on production of ticket/proof and proof of category.

17. Selection will be made on the basis of candidates' performance at the interview. The University may utilize seminar and/or colloquium as a method of selection.

18. The pay of the selected candidates will be fixed in the minimum scale/level of pay in the pay matrix. However, the candidates may apply for protection of pay and the University may consider the same strictly as per GoI rules for fixation of pay. Fixation of pay for re-employed pensioners shall be strictly as per pay fixation rules of re-employed pensioners.

Registrar

19. The appointment of candidates on regular basis shall be governed by the National Pension Scheme (NPS).

20. Candidates applying for more than one post should submit separate application for each post and should pay processing fee accordingly.

**21**. The teachers appointed shall be assigned with academic or administrative responsibilities in addition to their regular teaching and research activities.

22. No interim queries regarding test/interview/selection will be entertained.

23. Canvassing in any form will be a disqualification.

24. In case of any disputes, any suits or legal proceedings against the University, the jurisdiction shall be the Hon'ble High Court of Kerala.

25. Interested persons should apply along with two recent passport size photographs, photo copies of all supporting documents and processing fee of Rs 1,500/-. (SC/ST/Women and DA candidates exempted) in the form of DD from any nationalized bank drawn in favour of Central University of Kerala payable at Kasaragod.

**26**. The University will issue call letters to the shortlisted candidates and other correspondences through email only. Candidates are requested mention their email ID neatly and clearly in their applications.

**27**. Offer of appointment to the selected candidates will be issued after verifying the testimonials/qualifications/experience submitted by the candidate.

28. Any time after appointment should it become notice that the candidate do not possess the minimum eligibility prescribed by the UGC Regulations or that the claim made by him/her with respect to the qualifications/experience/other credentials are false or misrepresentation of facts, then his/her appointment shall be terminated forthwith. The candidate shall be held solely responsible for the same and its consequences.

**29.** Any errors and omissions detected in the advertisement and the process of selection are subject to rectification by the University.

**30.** The candidates are required to send all the relevant publications along with the hard copy of the application from for considering the candidature. The proof of peer reviewed journal status, impact factor, authorship claim etc. should be provided with valid documents, otherwise the marks will not be allotted as per the claim. University will not be responsible for any mistakes due to not providing valid proof.
