Research experience, if any, should be supported by certificate from the employer(s). Incomplete applications will be rejected.

The shortlisted candidates will be informed by email with details of interview date, time and venue.

A printed copy of the application form sent by email signed and dated by the applicant along with recent passport size photograph and photocopies of relevant certificates and other testimonials in support of age, qualification, experience etc. will be collected at the time of interview. Applicants must bring all certificates (original + one copy) at the time of interview for the purpose of verification.

General Information

1. Appointment is purely temporary and will terminate automatically without any notice or compensation on termination of the research project.
2. The appointed person shall have no claim of appointment / absorption in Funding Agency or in IISER Thiruvananthapuram.
3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. Applicants who do not meet the minimum criteria will not be considered. The prescribed educational qualifications are the bare minimum and mere possession of same does not entitle a candidate to be called for interview. Where number of applications received in response to this advertisement is large, it will not be convenient or possible to interview all the candidates. Based on the recommendations of the Screening Committee, the Project Leader/ Principal Investigator may restrict the number of candidates to be called for the interview to a reasonable limit after taking into consideration qualifications and experience over and above the minimum prescribed in the advertisement. Therefore, it will be in the interest of the candidates, to mention all the qualifications and experience in the relevant field at the time of applying.
6. No TA/DA will be admissible for appearing for the interview. Interviews may be conducted over skype video conferencing in exceptional cases.
7. Selected candidates will have to join duty immediately on receipt of the offer.
