AT PALAKKAD**

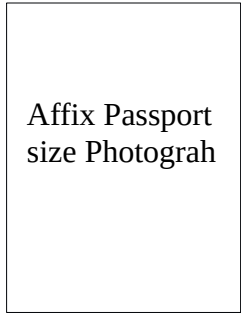

Appendix 'A'

Terms and Conditions of empanelment as counsel for ESI Corporation

1. The panel counsel will not take up any case against ESI Corporation and will relinquish the Vakalath in Pending cases, if any, against the ESI Corporation.
2. The representation on behalf of the Corporation is only in the cases/ matters which are specifically allotted / directed by the Regional Director of ESI Corporation, Kerala.
3. The rates of fee payable for initial entrusting of a case as per orders issued time to time are as follows:

Sl No	With Effect From	Court	Fee (₹)
1.	01 Jan 2017	District Court	12000
		EI Court, Magistrate Court and District Consumer Forum	5000

4. For all the re-entrusted cases, the counsel will be eligible for only the remaining part of the admissible fee after eligible fee of the previous counsel/ Counsels in the case.
5. While entrusted with a case the panel counsel shall be responsible for:
 - (i) Filing of written objection and counter affidavit promptly on receipt of statement of facts and related documents on priority basis.
 - (ii) Incorporation of citations of Hon'ble High Court and Supreme Court judgments wherever necessary and with value additions on the part of counsel.
 - (iii) Informing this office with regard to any short comings and serious omissions in the facts supplied or question of law and also in the base records and documents to supplement the same.
 - (iv) Reducing number of postings of the cases by effective role of the Advocate in presenting the Corporations stand before the court and presence in the Court as far as possible.
 - (v) Ensuring presence of the Counsel in the Court at the time of examination of the witness.
 - (vi) Effective argument and filling argument notes.

- (vii) Furnishing legal opinion on all judgments not later than one week on receipt of the Judgment copy so that filing of appeal is not delayed and to avoid condonation of delay and awarding cost by the High Court for such delays or causing rejection of the appeal.
