NOTIFICATION

The National Institute of Physical Medicine and Rehabilitation (NIPMR) is an autonomous organization under Social Justice Department, Government of Kerala invites applications from qualified and competent candidates for appointment to various posts **on contract basis**. Interested candidates may apply via **ONLINE** mode only by filling the prescribed application form given in the website of Centre for Management Development (CMD), Thiruvananthapuram (*www.cmdkerala.net*). The details are given below. The online application submission link will open on **15/09/2021(09.00 A.M.**). The last date for submitting online application is **29/09/2021 (05.00 P.M.**).

Note: Candidates will have to upload their passport size photograph (taken within six months), signature and copies of certificates proving qualification and experience while submitting the application. The photograph and signature must be in JPEG format. The size of the photograph must be less than 200 kB and the size of the signature should be less than 50 kB. The copies of certificates shall be either in JPEG format or in PDF format, and shall not exceed 3 MB in size.

Candidates should clearly mention the marks scored in their qualifying examination in the application. The conversion of grade/CGPA to percentage would be based on the procedure certified by the University from where they have obtained the degree. The onus of proving the conversion from grade/CGPA to percentage of marks would rest with the candidate.

In the event of any information provided by the candidate being found false or incorrect at any stage, their candidature/appointment is liable to be cancelled/terminated without any notice.
