

2. The selection will be made for the NHRIMH, Kottayam as indicated in the advertisement.
3. The eligibility of the candidates will be determined as on the last date of receipt of application.

The candidates who fulfill the eligibility requirement may apply in the prescribed format (**Annexure-I**) along with the self attested photocopies of the testimonials of qualifications, experience, marksheet, proof of date of birth, registration certificate, 02 passport size photographs. Entries in the application form should be supported by the relevant documents.
5. The engagement will be made initially for a period of one year. However, it may be curtailed or extend and depending upon the requirement of the Institute and/performance of the candidate.
6. For posts mentioned at S.No. 1 – 4 [Professor (PM), Professor (Psychiatry), Reader (PM) and Reader (Psychiatry)] , selected candidates will have to get themselves registered with the Travancore Cochin Medical Council within a period of one month of joining, if not already registered.
