NOTIFICATION

Centre for Management Development invites application from qualified and competent candidates for selection to the post of **Programme Manager**, on contract basis. Selected candidate will be deployed in the Project Management Unit (PMU) at Vizhinjam Port, to be set up by the Agency for New and Renewable Energy Research and Technology (ANERT). Interested candidates may apply via **ONLINE** mode only by filling the prescribed application form given in the website of Centre for Management Development (www.cmdkerala.net). The online application submission link will open on **26/04/2022 (09.00 A.M.)**. The last date for submitting the online application will be **10/05/2022 (05.00 P.M.)**.

Note: Candidates will have to upload their CV, passport size photograph (taken within six months), signature and copies of certificates proving qualification and experience while submitting the application. The photograph and signature must be in JPEG format. The size of the photograph must be less than 200 kB and the size of the signature should be less than 50 kB. The CV and copies of certificates shall be either in JPEG format or in PDF format, and shall not exceed 3 MB size.

NATURE OF APPOINTMENT

Candidate selected for the aforementioned post will be deployed in the Project Management Unit at Vizhinjam Port, to be set up by the Agency for New and Renewable Energy Research and Technology (ANERT), initially for a period of one year. Centre for Management Development can terminate the contract of the recruited staff if the Chief Executive Officer, ANERT intimates Centre for Management Development of poor conduct or unsatisfactory performance of the appointed candidate.

SELECTION METHODOLOGY

It shall be noted that admittance to various stages of the recruitment will be provisional only, and will not confer any claim unless various other conditions of selection are satisfied as per the prevailing rules of the organization. Detailed scrutiny of the applications/credentials will be conducted before interview/appointment. Any discrepancy found during the detailed scrutiny will result in the rejection of candidature.

Centre for Management Development reserves the right to shortlist only a limited number of candidates for written test/group discussion/interview, as the case may be for the post, based on marks secured in their qualifying examination and/or relevant experience. Candidate should clearly mention the marks scored in their qualifying examination in the application. The conversion of grade/CGPA to percentage would be based on the procedure certified by the University from where they have obtained the degree. The onus of proving the conversion from grade/CGPA to percentage of marks would rest with the candidate.

Canvassing in any form will lead to disqualification. In the event of any information provided by the candidate being found false or incorrect at any stage, their candidature/appointment is liable to be cancelled/terminated without any notice. Centre for Management Development reserves the right to fill or not fill the post advertised.
